

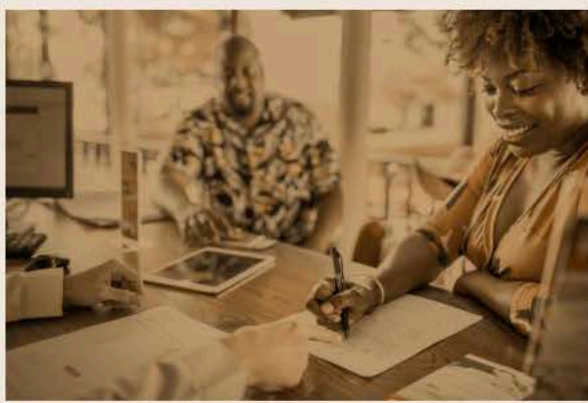
## Enjoy insurance insights with our new newsletter
